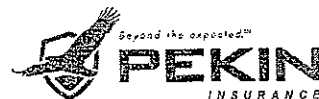



omissions of the Principal subsequent to said date.


