Subject: Freedom of Information Act Request - Village of Elmwood Park

Mr. Squeo:

The Village of Elmwood Park is in receipt of your August 12, 2011 Illinois Freedom of Information Act (5 ILCS 140/1 et seq.) ("FOIA") request. Below please find information assembled by the Village Clerk in response to your request.

Items # 1 and #2: 9 vehicles - Village Manager, Chief of Police, Deputy Chief of Police, Fire Chief, Deputy Fire Chief, Code Director, Water Department Superintendent, Health Director, Public Works Director.

Item # 3: Mileage records are not kept on any vehicle in the Village.

Item # 4: The Village's insurance cost for property and casualty is not provided on a "per vehicle" basis. Total cost for property and casualty insurance last year was \$299,204.00. The Village does not tabulate repair expenses per vehicle; instead, the Village keeps records regarding the overall expenses incurred with respect to all vehicles.

Item # 5: The Village maintains no documents which are responsive to your request.

The person responsible for the decision to deny a portion of your request is the Village of Elmwood Park Freedom of Information Officer, Elsie Sutter. In accordance with Section 9 (a) of the FOIA, you are hereby notified that you have the right to file a request for review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office. You can file your request for review with the Public Access Counselor by writing to:
