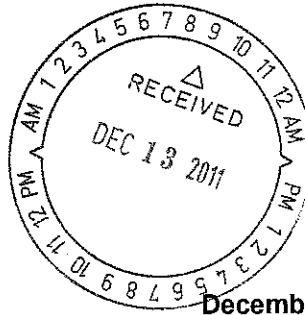

Re: Illinois Freedom of Information Act Request

December 10, 2011

Dear Elsie Sutter:

This is a request for information under the Illinois Freedom of Information Act, 5 ILCS 140. I request that the following be provided to me:

- The consulting agreement between Mack Communications, Inc. and the Village of Elmwood Park referenced in the Agenda for the November 21, 2011 Village Board meeting.
- Copies of any and all communications, whether written or electronic, between the Village of Elmwood Park and anyone else in any way related to the Village's relationship with Mack Communications, Inc.
- A copy of the resolution/ordinance of the consulting agreement with Mack Communications, Inc.
- Copies of all communications between Village employees and elected officials concerning the consulting agreement with Mack Communications, Inc. This request includes, but is not limited to, the documents provided to the trustees prior to the November 21, 2011 board meeting relative to the proposed consulting agreement.
- Considering the fact that there was absolutely no discussion concerning the details of the consulting agreement with Mack Communications, Inc., provide copies of the minutes of the meeting(s) at which point the trustees discussed the consulting agreement with Mack Communications, Inc.
- Copies of all emails, memos, letters, or other documents from any Village Official or employee, including but not limited to the Village Manager, the Assistant Village Manager, the Village Clerk, the Village President or the Assistant to the Village President, to any Village Trustee concerning the consulting agreement with Mack Communications, Inc. or the ordinance approving the consulting agreement with Mack Communications, Inc.
- Copies of all emails, memos, letters, or other documents from any Village Trustee to any Village Official or employee, including but not limited to the Village Manager, the Assistant Village Manager, the Village Clerk, another Village trustee, the village President and/or the Assistant to the Village President, concerning the consulting agreement with Mack Communications, Inc.
- Copies of any and all emails, memos, letters, or other documents to any Village official or Village employee from Mack Communications or any agent or employee of Mack Communications, Inc.
- Copies of any and all emails, memos, letters, or other documents to Mack Communications, Inc. or any agent or employee of Mack Communications from any Village official or Village employee.

I understand that the Act permits a public body to charge a reasonable copying fee not to exceed the actual cost of reproduction and not including the costs of any search or review of the records. 5ILCS 140/6

I request a waiver of all fees for this request. Disclosure of the requested information to me is in the public interest because it is likely to contribute significantly to public understanding of the operations or activities of the government and is not primarily in my commercial interest.

I look forward to hearing from you in writing within five working days, as required by the Act. 5
