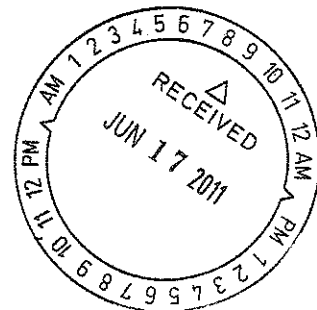

message: Pursuant to the Illinois Freedom of Information Act, 5 ILCS 140/1 et seq., this is a request for a copy of the following record(s):

- All objections filed against candidacy petitions for village elections in the last twenty (20) years.
- All objections filed against referendum petitions to be voted upon in village elections in the last twenty (20) years.
- All petitions against which such objections were filed.
- All electoral board decisions resulting from the filing of these same objections.

My preference is to receive these records in electronic form. If, in order to fully comply with this request, you would need to obtain records from an offsite location, please first provide us with the totality of records responsive to this request that are held onsite, then contact me to discuss the remaining records responsive to this request that are held offsite.

If any record or portion of a record responsive to this request is contained in a record or portion of a record deemed unresponsive to the request, I would like to inspect the entire document. Under the Freedom of Information Act, all non-exempt portions of any partially-exempt documents must be disclosed.

If any fee in excess of \$20 will be incurred in fulfilling this request, please obtain my approval before the fee is incurred. I request a waiver of any fees your office would ordinarily impose in responding to a request. I do not seek these records for commercial purposes and I intend to disseminate the information because disclosure is in the public interest in that it will help the Citizen Advocacy Center determine whether electoral board proceedings are uniform and equitable throughout the State of Illinois. Our findings will be made public upon completion of the research. We do not intend to use the response in any form for sale, resale, or solicitation or advertisement for sales or services.

In the event that this is not the responsible agency we ask that this letter be sent to the agency responsible for responding to this request.

If any records or portions of records are withheld, please state the exemption on which you rely, the basis on which the exemption is invoked, and the address to which an appeal should
