A response to your FOIA request will be made on or before May 27, 2011.

Dear Mr. Edwards:

I am in receipt of your Illinois Freedom of Information Act (5 ILCS 140/1 *et. seq.*) (hereinafter referred to as "FOIA") request received by the Village of Elmwood Park on May 13, 2011 for the following records:

- "•Permits, and any type of records related to construction work done on property located at 7715 W. Armitage, Elmwood Park, IL 60707, from January 1, 2007 to the present.
- Permits, and any type of records related to construction work done on property located at 2912 N. 77th Court, Elmwood Park, IL 60707, from January 1, 2007 to the present.
- Permits, and any type of records related to construction work done on property located at 1926 N. 75th Ave., Elmwood Park, IL 60707, from January 1, 2007 to the present."

Records responsive to your request are attached to the transmittal e-mail being sent to you. However, certain information has been deemed exempt from disclosure under the FOIA, and that information has been redacted from the records provided.


Section 7 (1) (b) of the FOIA provides that "private information" is exempt from disclosure. Private information is defined in the FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2 (c-5). Consequently, certain unique identifiers including home or personal telephone numbers and home addresses have been redacted from the records with which you are being provided.

The person responsible for the decision to deny a portion of your request is the Village of Elmwood Park Freedom of Information Officer, Elsie Sutter. In accordance with Section 9 (a) of the FOIA, you are hereby notified that you have the right to file a request for review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office. You can file your request for review with the Public Access Counselor by writing to:

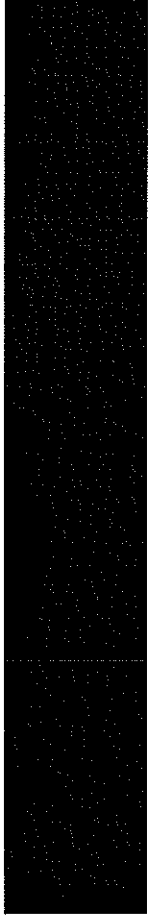
