Enclosed herewith please find copies of Arrest Reports submitted by the Elmwood Park Police Department. The Village maintains no other documents responsive to your request.



INCIDENT NARRATIVE

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

WHILE ON PATROL, I OBSERVED A WHITE VEHICLE, ILLINOIS REGISTRATION #71072N(TRUCK) DRIVING EASTBOUND ON WESTWOOD DRIVE IN THE NORTH ALLEY OF THE 7700 BLOCK WITH VARIOUS OBJECTS IN THE TRUCKBED. THE VEHICLE WAS IN VIOLATION OF COLLECTING JUNK ON A SUNDAY. I CALLED OVER THE MAIN RADIO BAND FOR A SUSPICIOUS VEHICLE. I ACTIVATED MY EMERGENCY LIGHTS AND CONDUCTED A TRAFFIC STOP AT THE 7700 BLOCK OF WESTWOOD DRIVE IN THE NORTH ALLEY. I APPROACHED THE VEHICLE AND SPOKE TO THE DRIVER, NOW KNOWN AS RAFAEL FABILA-MARTINEZ, AND REQUESTED HIS DRIVER'S LICENSE AND PROOF OF INSURANCE. I OBSERVED A JUNKING PERMIT FOR ELMWOOD PARK DISPLAYED ON HIS REAR-VIEW MIRROR. I INFORMED RAFAEL HE COULD NOT COLLECT JUNKING ITEMS ON SUNDAY IN ELMWOOD PARK. RAFAEL UNDERSTOOD AND PROVIDED ME WITH PROOF OF INSURANCE. RAFAEL TOLD ME HE DID NOT HAVE A DRIVER'S LICENSE. HE SAID HE HAS BEEN LIVING IN ILLINOIS FOR 8 MONTHS. I ASKED RAFAEL IF HE COULD PROVIDE ME WITH ANY KIND OF IDENTIFICATION. RAFAEL PROVIDED ME WITH A MEXICO CONSULAR IDENTIFICATION CARD AND A MEXICAN DRIVER'S LICENSE. UPON RUNNING RAFAEL'S NAME THROUGH LEADS, IT REVEALED RAFAEL DOES NOT HAVE A VALID DRIVER'S LICENSE. (625ILCS5/6-101) OFFICER RODRIGUEZ #2460 ARRIVED ON SCENE. I AGAIN APPROACHED THE VEHICLE AND REQUESTED RAFAEL TO EXIT THE VEHICLE, AND HE DID SO. RAFAEL WAS ADVISED HE WAS UNDER ARREST FOR DRIVING WITHOUT A VALID DRIVER'S LICENSE. RAFAEL WAS PUT INTO CUSTODY BY HANDCUFFING, DOUBLE-LOCKING, AND CHECKING FOR FIT THE TWO SETS OF HANDCUFFS DUE TO RAFAEL'S SIZE. RAFAEL INFORMED US HIS SON, ELIED SANTIAGO, IS THE REGISTERED OWNER OF THE VEHICLE AND HE HAD PERMISSION TO DRIVE THE VEHICLE. THE VEHICLE WAS SEIZED PURSUANT ELMWOOD PARK MUNICIPAL CODE 32-80. I RETRIEVED A CELL PHONE AND GPS SYSTEM (GARMIN) FROM THE VEHICLE, AT RAFAEL'S REQUEST. THESE ITEMS WERE LATER INVENTORIED WITH RAFAEL'S PROPERTY. RAFAEL WAS TRANSPORTED TO THE ELMWOOD PARK POLICE STATION, ESCORTED INTO THE BOOKING AREA, AND PROCESSED WITH ALL THE NECESSARY PRISONER SCREENING FORMS. RAFAEL WAS FINGERPRINTED, PHOTOGRAPHED, AND PROCESSED ACCORDING TO ELMWOOD PARK POLICE DEPARTMENT PROCEDURES. RAFAEL WAS ISSUED CITATIONS, ADVISED OF HIS COURT DATE, AND RELEASED ON BOND. RAFAEL WAS GIVEN HIS COMPLETED COPIES OF ADDENDUM A1-A3. TRAFFIC STOP AUDIO/VIDEO RECORDED.
