

	Jones told me she would like to file a formal complaint against Cicero for not allowing her to leave.
	I spoke to witness Anthony Zanner. Zanner said he heard the verbal argument between Cicero and Jones. He said he came outside of his residence at 2800 N. 73rd Court and saw Cicero aggressively pursuing Jones. He said as Jones attempted to get into her car Cicero blocked the door. Zanner said Jones was finally able enter her car. Zanner said he saw Jones start to back the car and Cicero run to the back to prevent her from proceeding.
