Dear Mr. Woodruff:

The Village of Elmwood Park is in receipt of your Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) (hereinafter referred to as "FOIA") request for "an electronic copy of six CAFRs – the years 1998-2003", which was received by the Village of Elmwood Park on July 26, 2013. Your request is denied because the Village of Elmwood Park does not maintain records responsive to your request. The Village of Elmwood Park does not have electronic files of Comprehensive Annual Financial Reports (CAFRs) for the requested six years. Electronic files of the Village of Elmwood Park's CAFRs date back to 2005.

The person responsible for the decision to deny your request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a request for review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office. 
