Dear Mr. Pesko:

The Village of Elmwood Park is in receipt of your February 13, 2013, Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) (hereinafter referred to as "FOIA") request for the following:

I am processing a refinance for Monica & Edwin Cubero. Their address is 1633 N. 76th Ct. Elmwood Park, IL 60707. Can you please provide any building permits that were issued from the date of the fire that destroyed your records through today? Also, if you have any info regarding the fire, please send that as well.

Enclosed please find documents responsive to your request. However, please be advised that certain information in the records being provided has been determined to be exempt from disclosure under the FOIA, and that information has been redacted from the records being provided.

Section 7(1)(b) of the FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in the FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including names attributable to home addresses and home or personal telephone numbers, have been redacted from the records being provided.


