Dear Mr. Koch:

The Village of Elmwood Park is in receipt of your July 8, 2013, Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) (hereinafter referred to as "FOIA") request for the following:

- (1) Stale-dated/Un-Cashed Checks Information
- (2) Cash Deposits/Performance Bonds/Cash Securities/Escrow Information
- (3) Property Tax Overpayments/Unclaimed Tax Lien Certificate Information.

Please be advised that your request is denied.

On July 15, 2013, the Village of Elmwood Park sent you electronic correspondence explaining that your request was categorical in nature, and compliance with your request would impose an undue burden upon the Village of Elmwood Park. This electronic correspondence extended to you the opportunity to reduce your request to manageable proportions. However, as of today, July 22, 2013, you have not conferred with the Village of Elmwood Park to reduce the scope of your request.

The Village of Elmwood Park is unable to comply with your request for records that does not specify a certain time frame, nor indicate the names of individuals, business entities, or property information attributable to the requested records without interfering with the daily operations of the Village of Elmwood Park. Therefore, pursuant to Section 3(g) of the FOIA, the Village of Elmwood Park has denied your request.


