

ORDINANCE NO. 2013- 17

**AN ORDINANCE AMENDING SECTION 18-25, ENTITLED  
"AMBULANCE/PARAMEDIC SERVICE PROGRAM," OF  
CHAPTER 18, ENTITLED "FIRE DEPARTMENT,"  
THE CODE OF THE VILLAGE OF ELMWOOD PARK**

WHEREAS, the corporate authorities of the Village of Elmwood Park desire to amend Section 18-25, entitled "Ambulance/Paramedic Service Program," of Chapter 18, entitled "Fire Department," in order to update the fee schedule for basic life support and advanced life support services provided by the Village.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Elmwood Park, Cook County, Illinois, as follows:

Section 1. Section 18-25, entitled "Ambulance/Paramedic Service Program," of Chapter 18, entitled "Fire Department," of the Code of the Village of Elmwood Park is hereby amended as follows:

**Sec. 18-25: Ambulance/Paramedic Service Program:**


Effective November 1, 2013, the recipients of basic life support services and/or advanced life support services from the ambulance/paramedic service program of the Village, and the recipients of other specified emergency services, shall pay a fee each time for the basic life support services and/or advanced life support services, or other specified emergency services provided to the recipient by the Village, for the usage and operation of the ambulance/paramedic program, or other specified emergency services, in an amount in accord with the following schedule:

<u>Service</u>	<u>Fee - Resident</u>	<u>Fee - Non-Resident</u>
Basic life support services – base rate	\$700.00	\$900.00
Advanced life support services – base rate (simple)	\$1,000.00	\$1,200.00
Advanced life support services – base rate (complex)	\$1,300.00	\$1,500.00
Mileage (basic life support services/advanced life support services)	\$20.00 per mile	\$22.00 per mile
Treat – No Transport	\$300.00	\$400.00
Extrication	\$400.00	\$500.00
Apparatus	\$125.00/vehicle/hour	\$125.00/vehicle/hour
Rescue Worker	\$35.00/firefighter/hour	\$35.00/firefighter/hour


Section 2. This Ordinance shall be in full force and effect on November 1, 2013,  
after its approval and publication as provided by law.
