**Freedom of Information Act/Open Public Records Request – 5 ILCS 140/1**

Pursuant to the Illinois Public Information Act ("PIA" or the "Act"), codified in the State Government Article of the Illinois Code 5 ILCS 140/1 the following is a request for a copy of any and all of the Village of Elmwood Park Illinois Outstanding / Stale-dated check lists, which may also be known as Limited Payability Cancellation Reports of refunds and credits (Undeliverable checks); specifically the undeliverable checks for individuals, businesses and vendors. If possible, please indicate or eliminate any checks or accounts that have been or are presently being reissued. We would like for the list to include all outstanding items that are currently available for reissue by the Village upon written request.

We would like the unclaimed items to be not more than five years old. Please eliminate all items under \$1000.00.

I understand from other agencies that certain fields on the report may be confidential so we restrict our request to the check number, check date, amount of the check, agency code or reference number, and payee name and address. However, if it is simpler and more cost effective to send the entire report, we can work around the extra fields.
