The Village of Elmwood Park is in receipt of your April 11, 2014 Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

[C]opies of any and all run reports as well as any and all corresponding invoices and proof of payments from Jan. 1, 2011 to today for any and all incidents in which a person was charged for fire/EMS response to a vehicle accident, including but not limited to charges for chief response, additional personnel and engine assistance. Please note: I am only looking for incidents in which there were any additional response charges beyond the standard ALS or BLS ambulance fees.

Your request is denied because the Village of Elmwood Park maintains no documents which are responsive to your request. Please be advised that the Village of Elmwood Park Fire Department does not assess fees for any of the services specified in your request.
