The Village of Elmwood Park is in receipt of your July 30, 2014 Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

A certified copy of the record responsive to your FOIA request is available for pickup at the Village of Elmwood Park Village Hall, 11 Conti Parkway, Elmwood Park, Illinois 60707. Pursuant to Section 6(b) of FOIA, the Village of Elmwood Park charges One and 00/100ths (\$1.00) Dollar for certifying documents. Therefore, when you pick up the document responsive to your FOIA request, please remit payment to the Village of Elmwood Park in the amount of One and 00/100ths (\$1.00) Dollar. However, please be advised that certain information in the record responsive to your FOIA request has been determined to be exempt from disclosure under FOIA, and that information has been redacted from the record being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, a certain unique identifier, specifically a signature, has been redacted from the record being provided.


