**Re: *Freedom of Information Act Request***

Dear Mr. DeBruin:

The Village of Elmwood Park is in receipt of your December 13, 2013 Illinois Freedom of Information Act (5 ILCS 140/1 et seq.) ("FOIA") request, which was received by the Village of Elmwood Park on December 16, 2013, for the following records:

[A]ll addresses of all Lawn Sprinkler Permits issued in residential homes in your city, from 2000 to 2013, containing the following information: Addresses.

On December 31, 2013, the Village of Elmwood Park sent you documents responsive to your FOIA request. Unfortunately, the documents sent to you on December 31, 2013, were not responsive to your FOIA request. I apologize for any inconvenience this may have caused. Enclosed please find the correct records responsive to your FOIA request. However, please be advised that certain information in the records being provided has been determined to be exempt from disclosure under FOIA, and that information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain


unique identifiers, including home or personal telephone numbers and names attributable to home addresses, have been redacted from the records being provided.
