Dear Mr. Devereux:

The Village of Elmwood Park is in receipt of your July 21, 2014 Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

ANY AND ALL POLICE REPORTS RELATING TO A TRAFFIC ACCIDENT
ON EITHER JULY 16-17, 2014, AT APPROXIMATELY 78TH COURT AND
NORTH AVENUE IN ELMWOOD PARK INVOLVING PAUL LEWIS.

Certified copies of the records responsive to your FOIA request are available for pickup at the Village of Elmwood Park Village Hall, 11 Conti Parkway, Elmwood Park, Illinois 60707. Pursuant to Section 6(b) of FOIA, the Village of Elmwood Park charges one and 00/100ths (\$1.00) dollar for certifying documents. Therefore, when you pick up the documents responsive to your FOIA request, please remit payment to the Village of Elmwood Park in the amount of one and 00/100ths (\$1.00) dollar. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA, and that information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain

unique identifiers, including a driver's license number, employee identification numbers, home or personal telephone numbers, home addresses, a personal license plate, and a signature, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy ..." is exempt from disclosure. Consequently, birthdates have been redacted from the records being provided.



In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office. If you choose to file a Request for Review with the Public Access Counselor, you must do so within 60 calendar days of the date of this letter. Please note that you must include a copy of your original FOIA request and this letter when filing a Request for Review with the Public Access Counselor.

Also, you are notified that you have the right to judicial review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer pursuant to Section 11 of FOIA.
