Dear Shyamkumar Narayana:

On February 25, 2014, the Village of Elmwood Park received your Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

Need the Architect details (Name, Phone number, Address, E-mail id etc.) of the Architect who designed my house in Year 2003 – Year 2009 Time frame.

Enclosed are records responsive to your request. However, please be advised that certain information in the records being provided has been determined to be exempt from disclosure under FOIA, and that information has been redacted from the records being provided.

Section 7(1)(k) of FOIA provides that the following records are exempt from disclosure:

Architects' plans, engineers' technical submissions, and other construction related technical documents for projects not constructed or developed in whole or in part with public funds and the same for projects constructed or developed with public funds, including but not limited to power generating and distribution stations and other transmission and distribution facilities, water treatment facilities, airport facilities, sport stadiums, convention centers, and all government owned, operated, or occupied buildings, but only to the extent that disclosure would compromise security.

Consequently, architects' plans for projects not constructed or developed in whole or in part with public funds have been redacted from the records being provided.

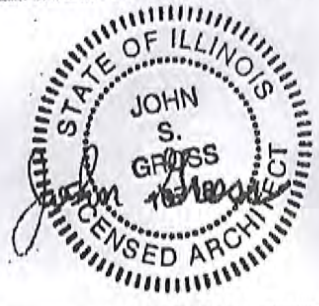
