Re: Freedom of Information Act Request

Dear Mr. Zenkevicius:

On October 21, 2014, the Village of Elmwood Park received your Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

"Please provide us with the building violations list (if any) for the property located at 2626 N. 74th Avenue Elmwood Park, IL. 60707.

Also, let us know if this property has outstanding liens, bills, or invoices that must be paid.

Send us any actual invoices."

Your FOIA request is granted in part and denied in part. Enclosed are records responsive to your FOIA request. The Village of Elmwood Park has not withheld any records responsive to your FOIA request. However, please be advised that certain information in the records being provided has been determined to be exempt from disclosure under FOIA, and that information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain

unique identifiers, including home or personal telephone numbers and names attributable to a home address, have been redacted from the records being provided.


