The Village of Elmwood Park is in receipt of your August 27, 2014 Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

Your FOIA request is granted in part and denied in part. Enclosed is a record responsive to your FOIA request. However, please be advised that certain information in the record being provided has been determined to be exempt from disclosure under FOIA, and that information has been redacted from the record being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including a home or personal telephone number and a name attributable to a home address, have been redacted from the record being provided.


