Re: Freedom of Information Act Request

Dear Mr. Craig:

On July 23, 2015, the Village of Elmwood Park received your Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for "15-7089."

Enclosed please find the records responsive to your FOIA request. However, please be advised that certain information in the records being provided has been determined to be exempt from disclosure under FOIA. Accordingly, information that has been determined to be exempt from disclosure under FOIA has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including a driver's license number, personal financial information, home or personal telephone numbers, home addresses, and signatures, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy ..." is exempt from disclosure. Consequently, birthdates and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, such as a victim's name and identifying information, and the race of individuals, have been redacted from the records being provided.

Section 7(1)(d)(iv) of FOIA provides that, “[r]ecords in the possession of any public body created in the course of administrative enforcement proceedings, and any law enforcement or correctional agency for law enforcement purposes ...” are exempt from disclosure, “but only to the extent that disclosure would: ... unavoidably disclose the identity of a confidential source, confidential information furnished only by the confidential source, or persons who file complaints with or provide information to administrative, investigative, law enforcement, or penal agencies” Consequently, information that would reveal the identity of persons who have filed complaints with or who have provided information to the Village of Elmwood Park Police Department has been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. The 6 units on the north end of the building utilize the 7901 W Grand address, the 3 on the southern end use 2534 N 79th Avenue. Entry had been forced into 2534 N 79th Avenue, GS and 1S (15-7091). Keys had been taken from inside GS and utilized to gain entry to 7901 W Grand, BW. None of the three units were being rented out. All were being used as storage by [REDACTED] and his building maintenance supervisor [REDACTED] also stated [REDACTED] has belongings in the bedroom of 7901-BW.</p> <p>-See Continuation-</p>

I walked through each of the 3 units with [REDACTED] while OFC Schak canvassed the remainder of the building.

Entry had been forced into 2534-GS. The apartment was being used by [REDACTED] as storage and housed a large quantity of tools. After he spoke with building maintainer [REDACTED] concluded the following items had been taken out of the unit:

- A 14" Chicago Electric cut off saw, silver and maroon in color.
- A wooden "carpenter's box" containing 10 14" saw blades for the Chicago Electric saw.
- A dark green Masterforce air compressor, the cord of which was bundled with a bright orange cable cuff.
- 2 sets of keys: 1 set consisted of a Jeep key with FOB. The other set was a dog chain with multiple snow blower keys and the keys to 7901 W Grand, BW.

[REDACTED] and I walked through 2534-1S. Entry had been forced into 1S. The unit was being used for storage. According to [REDACTED] the unit had been gone through, but nothing was missing. I later spoke with 7901 [REDACTED] resident [REDACTED] who stated that he had slipped a money order under the door of 2534-1S at approximately 0500 hours on 07-20-15. The money order, issued by the Belmont Cicero Currency Exchange for \$200.00, had been taken from 1S. Mendez was able to provide me with the receipt for the money order which was entered into BEAST.

I walked through 7901-BW with [REDACTED] did not believe anything had been taken from the unit. [REDACTED] who has a room in the unit, was not on scene. [REDACTED] was unsure if any of [REDACTED] belongings had been disturbed.

Ofc Brand arrived on scene as an Evidence Technician. He photographed the building and each of the 3 units. He advised me he had not located anything of evidentiary value. He placed the photographs into BEAST.

In addition the individuals OFC Schak spoke with during his canvass, I spoke with the following persons:

[REDACTED] (F/[REDACTED]) tx [REDACTED], who resides at 7901 W Grand- [REDACTED] (across the hall from 2534-1S), stated she believed she had observed the wood particles/debris, caused when entry was forced, at 2230 hours on Saturday 07-19-15. She stated the door was closed and assumed the debris was the result of maintenance work.

[REDACTED] (M/[REDACTED]) tx [REDACTED], who resides at 7901 W Grand- [REDACTED] (across the hall from 2534-GS), stated he had exited his unit at 0515 hours on 07-20-15. At that time the door to 2534-GS was undamaged and unobstructed. He proceeded up the stairwell and placed the \$200.00 money order underneath the door of 2534-1S. The door to 2534-1S was undamaged and locked. When he returned home from work at 1700 hours he noticed a large fan outside of the doorway to 2534-GS that had not been there earlier at 0515 hours.

-On 07-21-15 at approximately 1600 hours I spoke on the phone with resident [REDACTED] (who had not been home on 07-20-15). [REDACTED] who resides at 7901 W Grand- [REDACTED] and can be reached at [REDACTED], relayed the following:

On 07-20-15 at 1600 hours he arrived home from work and parked his vehicle south of the building. He observed a slender M/B, 601/180 in his early 30s, exit a vehicle and proceed to stand on the east side of the building. The M/B; who was wearing tan shorts, a white tshirt, and a black hat, had gotten out of a black 4D Chevy Lumina. The M/B, whom [REDACTED] noted was very dark in complexion, acted as if he were serving as a look out.

[REDACTED] then entered the building through its west entrance. As he entered, he looked down the stairwell and observed a second M/B. The M/B in his 20s, who also had a very dark complexion, was 508/165 and had shoulder length dreadlocks. [REDACTED] stated the M/B was wearing *True Religion* brand blue jeans with white threading. He observed the M/B walking from 7901-BW towards the laundry room/west entrance to 2534-GS. The M/B was carrying a cardboard box with both arms, but [REDACTED] was unable to view the contents of the box.

On 07-21-15 [REDACTED] phoned the EPPD and advised me he had contacted the Belmont Cicero Currency Exchanged to inquire about the money order. He was advised an individual had attempted to cash the order, but had been denied due to lack of proper identification. [REDACTED] was advised by the employee that no further information could be given to him on the matter.
