Re: Freedom of Information Act Request

Dear Mr. Fiore:

The Village of Elmwood Park is in receipt of your August 20, 2015, Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following record:

"Please send a copy of letter sent to Barbara Kubska-Lewczuk at 2602 N. 74th CT; apt #2 Elmwood Park, IL 60707 for failure to obtain a [*sic*] electrical permit for electrical work done in her apt./condo. She was to pick-up and pay for permit as part of the contract."

Enclosed is the record responsive to your FOIA request. However, please be advised that certain information in the record responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the record being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including a home address and a signature, have been redacted from the record being provided.
