**Re: Freedom of Information Act Request**

Dear Ms. Soto:

On December 28, 2015, the Village of Elmwood Park received your Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for "Report # 15-10307[.]"

Enclosed please find certified copies of the records responsive to your FOIA request. Pursuant to Section 6(b) of FOIA, the Village of Elmwood Park charges One (\$1.00) Dollar for certifying documents. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including a home or personal telephone number, a home address, and a personal license plate, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy,

including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office. If you choose to file a Request for Review with the Public Access Counselor, you must do so within 60 calendar days of the date of this letter. Please note that you must include a copy of your original FOIA request and this letter when filing a Request for Review with the Public Access Counselor.

You are also notified that you have the right to judicial review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer pursuant to Section 11 of FOIA.

THE INFORMATION BELOW IS CONFIDENTIAL - FOR USE BY AUTHORIZED PERSONNEL ONLY

On 12/25/15, at approximately 0411 hours, I was dispatched to a Motor Vehicle Theft call at 7930 W. Wellington Avenue.

Upon arrival, I spoke with [REDACTED] (F/ [REDACTED] DOB [REDACTED]) who stated she arrived home at approximately 0030 hours and noticed her vehicle, a 2005 silver, Chevy Equinox, missing at approximately 0230 hours. [REDACTED] said she went out with a female, black, by the name of "Bean," earlier in the evening at 2100 W. Randolph in Chicago. [REDACTED] said she met "Bean" only a few times and that is all the information she had on her. She said they had a few drinks at "Bean's" residence and [REDACTED] starting to feel ill from the alcohol. [REDACTED] said she told "Bean" she needed to drive her home and for someone to follow them so "Bean" could get back after she dropped her off. She said she arrived home, "Bean" exited her vehicle and left with an unknown male in another vehicle. [REDACTED] said at approximately 0230 hours, she asked her brother to make sure her vehicle was locked and he told her he did not see the vehicle where it was supposed to be parked. [REDACTED] said she attempted to contact "Bean" but was unsuccessful. [REDACTED] said she did not owe any money on the vehicle so she did not believe it would be repossessed. [REDACTED] did not know the license plate number or vin number to the vehicle and all of her possessions were in the vehicle when it was stolen. The only information [REDACTED] could offer was that the vehicle was registered in her name to [REDACTED] said she had both keys in her possession and no one else had access to the vehicle. She said her Michael Kors, black wallet was left inside the vehicle with her identification, Visa card and birth certificate inside it.

I advised Wescom to contact Chicago PD to check the area of 2100 W. Randolph to see if they could locate the vehicle. At the time of the report, Chicago had not responded to our request.

Officer Chaurize contacted Lafayette PD which advised her of the license plate and vin numbers. (IN Reg- [REDACTED] and 2CNDL73F056005744)

I faxed Wescom a copy of the report to enter the vehicle into LEADS.
