GENERAL VILLAGE INFORMATION

The Village of Elmwood Park was incorporated on April 8, 1914, and operates under a Village Manager form of government. It is a home rule community as defined by the Illinois Constitution, Elmwood Park is located approximately twelve miles from the City of Chicago, and about eight miles from Lake Michigan. The Village is primarily a residential community of single-family homes, newer condominiums and town homes, but also includes several business districts and a small industrial area. In the 2000 census, there were 24,405 residents in Elmwood Park. As of July 2009, there are 23,926 residents.

Policy making and legislative authority are vested in the Village Board which consists of the Village President and six Trustees. This governing body is responsible, among other things, for passing ordinances, adopting the budget, approving policies, and appointing the Village Manager and the Village Attorney. The Village President, the Village Board and the Village Clerk are elected at-large to four-year terms. The Village Manager and the Village Attorney are appointed by and serve at the discretion of the Village Board.

The Village provides many services for its residents and businesses. The purpose of the Village is to provide local governmental services within its corporate limits.
