Mr. Forte conveyed, on behalf of the family of Mrs. Miceli who passed away recently, their heartfelt appreciation for all the help and the sympathy the Village has shown. Mrs. Miceli's son-in-law, retired Deputy Chief George Bertucci, commended the Fire and Police Departments for their assistance and also expressed his thanks to both Fire Chief Marino and Police Chief Braglia.

With reference to the Garden Club, this year's project will be to place flowers around the Post Office. Authorization was given by the Postmaster.

Mr. Kaminski reported that he had the privilege of attending, along with the President, the Eagle Scout Ceremony for Mr. Joseph Baratta and he congratulated his parents and family on the great achievements that he has made.

MANAGER'S REPORT

Mr. Dalicandro reported that Fire Chief Michael Marino informed him that the recent tragedy in Homewood possibly could have been prevented. He has instructed his department to clearly report the address of any person who has oxygen tanks in their homes.

The Chicago Sun-Times recently printed a graphic that provides the path that all solid waste travels from Elmwood Park residents to the Metropolitan Reclamation District of Greater Chicago. He shared this graphic with the President and Board.

Lastly, a letter from Storino, Ramello and Durkin was circulated to the Board regarding Legislative Update Concerning Requirements under Title II of the Americans with Disabilities Act and Authority of Municipalities Regarding Foreclosed Properties.

PRESIDENT'S REPORT

President Silvestri advised the Board that he received a copy of the Highway Improvement Program for the State of Illinois from State Representative Saviano. It indicates that Grand Avenue, a State of Illinois route, is to be resurfaced in the summer of 2011. This is a 1.9 million dollar project and it covers Grand Avenue from Harlem Avenue in Elmwood Park to Elm Street in River Grove.

Also, in the year 2012 to 2016 program, the bridge on the Des Plaines River on North Avenue will be replaced; an 8.3 million dollar project. The Belmont Avenue intersection at 76th Avenue/Oriole will also be a reconstruction. This is all subject to financial constraints.

President Silvestri also reported that Congressman Quigley visited Elmwood Park to do jobs of what other people do. He worked at Connie's Beef on Grand Avenue. It was also reported in the New York Times.

President Silvestri, Trustee Bennett and Clerk Sutter visited the rededication of the Elmwood Care Nursing Home on Grand Avenue. This place was changed from a clinical type place to a more modern and friendly facility.

The President reported that the 2010 Village Budget Summary can be read on the Village website and Facebook. This summary is very informative and details budget reductions anticipated in the new budget.
