# **REPORTS OF COMMITTEES AND TRUSTEES**

The Village Clerk read a note to the Village President, Board and Village Hall staff from Elsie Sutter thanking them for the lovely flowers, support and encouragement during the difficult time of her husband's passing.

Mr. Kaminski reported that he attended the O'Hare Noise Compatibility Commission's general business meeting. American Airlines gave an extended report on the average life of their fleet mix which is fourteen years. Mr. Kaminski noted that we just approved the replacement of dump trucks that are over twenty four years old, highlighting the need to routinely replace our capital equipment. He also spoke about local schools in the area being recipients of sound proofing from this commission.

Mr. Lollino reported that the planning of the 4<sup>th</sup> of July events are well underway. This year's parade will follow a longer route. The parade will kick off at 10:00am in the circle and will return to the North side of town before ending at Westbrook and Fullerton. Many local businesses, Police and Fire Department, Elmwood Park High School marching band, New Polonia Dancers and others will be in this year's parade. The gates at the high school will open at 5:00pm and will feature music, food and fireworks. He thanked the 4<sup>th</sup> of July committee for all their efforts.

Mr. DelSanto reported that he attended this years "Relay For Life" this past weekend at Elmwood Park High School. The event was well attended and raised just over \$25,000.00 for cancer research.

Ms. Stranges reported that the "Keep Elmwood Park Beautiful" committee is planning a community clean-up day September 7<sup>th</sup>, 2013 focusing on the business districts, recognizing businesses that are keeping their storefronts clean. The Arts and Special Events commission is planning another community bike ride on June 27<sup>th</sup> in conjunction with the concert in the park. The "Kids Day" at the Farmers Market on June 9<sup>th</sup> was well attended by the community and was enjoyed by all.

Village attorney Michael Durkin reported there are two ordinances on the agenda tonight. The first one is regarding the declaration of the general prevailing rate of hourly wages for the year 2013. Two sections of this ordinance are pointed out to the new village clerk for extra review and action.

#### **MANAGER'S REPORT**

Mr. Volpe reports on the bid opening for the MFT roadway projects, work on the Firehouse One driveway, Central Park painting, Opt-in Electric Aggregation, Village canvass, Cook County Sherriff's SWAP program and the ordinance amendment for antique vehicle licenses. A full copy of his report is attached hereto.

#### PRESIDENT'S REPORT

President Saviano commented on the community canvass that Mr. Volpe reported on. He reported that the overall condition of property in the Village is better than last year. President Saviano also sponsored and attended the "Memorial Bike Run" for Lance Corporal Nick Daniels on June 8<sup>th</sup>. It was an all day event that was well received. He commended everyone who pitched in to make it successful.

# **COMMUNICATIONS**

The clerk read a letter from Rev. Sagil of New Horizons Temple requesting permission to fundraise at various locations in the Village for their "Save Our Children" program. A motion was made by Mr. Kaminski and seconded by Mr. Sargent to approve the request. Motion carried.

The clerk read a letter from Ms. Nancy Tibbits of the Elmwood Park Women's Club requesting special date for rummage sale at the Parks and Recreation Center.

President Saviano stated it would be based on the availability of the recreation center. The clerk will forward a copy of the letter and dates requested to Mr. Al Schmidt for review. A motion was made by Mr. DelSanto and seconded by Ms. Stranges to approve the request. Motion carried.

The clerk read a letter from Connie Payton of the Payton Foundation requesting a donation from the Village to renovate an apartment at Concord Place for homeless veterans. President Saviano stated that he attended a Mayors Meeting where this was brought up and most of the surrounding towns are being asked to participate. President Saviano asks that this be forwarded to the Finance Committee for review.

# **RESOLUTIONS**

The clerk read the Resolution Honoring Peter Papas, a longtime resident of the Village who passed away on May 22, 2013. Mr. Papas was a war hero and a caring individual who made a difference in many lives. A motion was made by Mr. DelSanto and seconded by Mr. Sargent to approve the resolution. Motion carried.
