The department donated a total of \$1000.00, some of which was raised at the Fire Department chili booth at this year's Fall Fest. This money will be used for the Illinois Fire Safety Alliance burn camp.

# **ADJOURNMENT**



Manager's Report

#### **Leaf Program**

The leaf program will begin on Monday October 26, 2015 and run through Friday December 4, 2015. Residents are asked to rake leaves into the street a day or two before collection is scheduled. Collection will take place on the designated street cleaning day. Branches and grass clippings should not be raked into the pile of leaves but should instead be placed into yard waste bags. Yard waste bags will be picked up by Groot until November 20<sup>th</sup>. No stickers are required on the yard waste bags.

#### Loan with Belmont Bank & Trust

The Board will be asked to consider an ordinance to approve a loan with Belmont Bank & Trust. The loan amount is \$2 million. The term is ten years. The interest rate is fixed at 2.65%. The proceeds of the loan will be used for the street improvement program. The Village solicited interest from the four banks with whom we have an active relationship. Belmont Bank and Trust offered the lowest interest rate.

#### **Update on Parking Lot**

We have begun construction of the parking lot at 1612 N. 74<sup>th</sup> Court. Concrete and paving are scheduled to be complete this construction season. Lighting and landscaping will be completed as soon as possible but will likely be completed in the spring.
