THE 2,184th REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES VILLAGE OF ELMWOOD PARK

November 16, 2015


ADJOURNMENT

Manager's Report

Insurance Renewal

The Board will be asked to approve the acceptance of a proposal to renew our property, casualty and workers compensation insurance for the period beginning December 1, 2015 and ending December 1, 2016. The Village's insurance broker Mesirow Insurance Services, Inc. recommends that we accept a proposal from the Illinois Counties Risk Management Trust (ICRMT.) The Village's property and casualty premium with a worker's compensation program that includes a \$300,000 self-insured retention is increasing by 7.64% to \$1,177,268.

Retirement Plan Services Request for Information (RFI)

On November 6, 2015 the Village issued an RFI for Retirement Plan Services including plan administration, recordkeeping, participant enrollment and advice. The Village currently maintains ICMA-RC as its plan provider. With this RFI, we seek to understand what the current market offers to a plan of our size. We, of course, reserve our right to take no action on this RFI. Responses are due December 7, 2015. A copy of the RFI can be found on the Village web-site.
